IV. Moved by Dana Wrigley seconded by David Groder and voted 4-0 to approve the minutes from the September 25, 2024, Council meeting and signing the weekly payables warrant.

V. Business Agenda:

**Old Business:**

1. Order 22-2425 Moved by Dana Wrigley seconded by David Groder and voted 4-0 to approve the second reading of the amendments to the General Assistance Maximums along with the updated version of the MMA's General Assistance ordinance dated September 2024.

3. Order 23-2425 Councilors signed the November 5, 2024, Municipal Warrant Election

4. Order 24-2425 Moved by Dana Wrigley seconded by Robert Nutting and voted 4-0 to approve the road name being "Reisling Estates" which is an extension of Autum Lane and road name "Martha Estates" located off the East Pond Road.

5. Order 25-2425 Manager provided updated information pertaining to the ATV Park -N-Ride – Trail Head. There is a possibility of a second option which would require cutting down of trees at the location. The state has agreed to pay for survey and boundary information. Kelly Roderick stated that cars are already parking at Wrigley Field, at all times of the day. Councilors agreed that signage is needed in this location to inform the public that this area is **currently not** a park and ride location. Signs will be ordered.

6. Order 26-2425 The Town Office will be closed on Election Day, November 5<sup>th</sup>, which will allow town employees to assist throughout the day at the polls. Polls will be open from 7:00 to 8:00 pm.

7. Order 27-2425 Manager provided information relative to the PFML-Paid Family Medical Leave – act that becomes effective January 1<sup>st</sup>, 2025. Currently the program is **not** optional, it requires the town to deduct .5% from employee checks, each week, and the town is also required to match with their .5%.

8. Order 28-2425 Moved by Dana Wrigley seconded by Robert Nutting and voted 4-0 approving the 3.4% (COLA) CPI/Northeast for Manager's use in preparing the upcoming 2025-2026 budget.

## **Manager Updates**

Moved by Robert Nutting seconded by Dana Wrigley and voted 4-0 to approve the use of \$7,000 for Phase I Assessment of Memorial Hall. Currently the Memorial Hall fund has \$70,000, from fund raising and donations.
